Many of you may already listen to **Living on Earth**, an environmental news show on public radio at 9 AM on Sundays. However, if you sleep in on Sundays or are in church or the forest by 9 AM, you can get the program on your computer at any time by logging on to << [www.loe.org](http://www.loe.org) >>. It has pictures and audio and a menu of all the subjects covered by the last show. Also, you can listen to a previous show through their archives.

Another great source for environmental information is ENN, or **Environmental News Network**. They collect the environmental news from across the country and around the world from radio stations and other news sources. Many of the articles are text and many are audio. Of course, we can't forget **Sierra Club National Web Page**. You get there by typing in <<[www.sierraclub.org](http://www.sierraclub.org)>>. On this website, you can view the current issue and back issues for Sierra magazine and of The Planet, which is the Sierra Club Activist monthly newsletter. You can also find out more about the Sierra Club, get issues updates on the top priority national Sierra Club issues, plus daily environmental updates, plus how your U. S. Senators and representative voted on recent bills in Congress, plus more. ### **Shawnee Forest Plan Timetable for Input**

On July 27th, and possibly continuing on August 3, the Shawnee Forest supervisor is holding a meeting to try to find common ground or some common "vision" of how we want Shawnee Forest to be managed under the next Shawnee Forest Plan. In the latest FS mailing, the Shawnee Forest supervisor, Skip Starkey, has laid out a new timetable for the forest planning process. The Notice of Intent will be issued December, 2000, and issue finalization will be June, 2001. Next is "Developing Alternatives" around December 2001. Then the Draft Forest Plan comes out around June, 2003, and the Final Plan around June, 2004. We need to give maximum input at all of these stages, but early input is probably the most crucial. If you cannot attend the meetings on July 27th and/or August 3rd, you can write a letter giving a general statement of what your vision of the ideal Shawnee Forest would be, and mail it to:

### **The Sierra Club Vision For Shawnee Forest**

We have not totally spelled out our vision - it is the "work in progress" called the "Citizen's Forest Plan." However, we really have a pretty good idea of what that vision includes. **We want an intact forest that remains as natural as possible, and that provides a safe, quiet sanctuary for the many threatened, endangered and rare plants, plant communities, and animals found in Shawnee Forest, with adequate access for people compatible with maintenance of environmental integrity.** We also want the following:

- Preserve and protect the biological diversity and integrity of the 80 Illinois designated Natural Areas.
- Maintain the status for the current wilderness areas, and have three more areas designated as "wilderness study areas" - Burke Branch, Ripple Hollow, and Camp Hutchins, with better management to maintain the wilderness character of these areas.
- Designate and maintain a high quality hiker/equestrian trail system that is well marked, and well maintained in all areas including wilderness areas, but excluding the 5% of the forest that is the designated Natural Areas.
- Restrict horses to the extensive designated hiker/equestrian trail system.
- Maintain Shawnee Forest as a haven of peace and quiet, and protect the flora and fauna of the forest from the highly destructive effects of, motorized vehicles by totally excluding all motorized vehicles from forest trails. Motorized use restricted to licensed vehicles on forest roads only.
- No commercial timber cutting (less than 4% of wood/wood products in U.S. come from public land).
- An environmentally sound plan for protecting Shawnee Forest from further invasion by exotic species.
- Minimize disturbance of the Forest by not allowing surface mining or oil & gas drilling on the forest, including no new leases for mining, oil or gas.
- Minimize fragmentation of the Forest by buying inholdings and areas that consolidate fragmented areas of Shawnee Forest.
- Obliteration of all user-made trails that are not suitable for inclusion in the Forest system trail inventory, plus obliteration of forest roads that are no longer needed (most only old logging roads)

This is not a comprehensive list, but it is a start. Now, write down your "wish list" or "vision" for Shawnee Forest and send it to the forest supervisor, Skip Starkey (see address above). **Do it today!**

### **Off-Road Vehicle Users and Horse Campground Owners - Their Vision--**

The Shawnee Trail Conservancy and the Southern Illinois Campground and Ranch Owners Association have a vision of Shawnee Forest that is very different from our vision. I think it is very useful to be aware of their goals for the forest. In written comments to the Forest Service for the comment period on the new Shawnee Forest Plan, the president of Shawnee Trail Conservancy (an ATVer and motocross racer) listed twenty-three

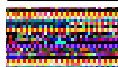
goals that they have for the forest (we had their official comments copied at the USFS office). They want at least 286 miles of ATV trails. They label these trails as ATV/Equestrian/Hiker trails, but who wants to be riding their horse or hiking on a trail where ATVs may zoom past at any moment. Just the noise from those raucous machines could scare a horse or interrupt a peaceful walk. **They want the Forest Service to abandon all the 80 Designated Natural Areas and all present wilderness areas, and let everyone ride horses and ATVs through them.** They advocate more timber harvesting. They want all old roads that were ever county roads to be returned to the counties so that all vehicles (jeeps, trucks, everything) can ride on them through the forest. They want to "Use a common sense approach to the endangered species act. Limit the use of this over used tactic to stop good sound management of our Forest." **They want an equestrian trail system developed through several research natural areas.** This is the view that many horse riders have been duped into believing they have to support in order to get the horse trails they want. **Horse riders are free to ride through 95% of the forest.** Horses are allowed in wilderness areas and every part of the forest except the 80 designated Natural Areas. **The truth is the leaders of the two groups mentioned above want 4-wheelers, jeeps, motorcycles, etc., to be able to ride throughout the forest,** and the horse campground owners want to make a profit off of the forest by taking people through many of the 80 Natural Areas on horses. **These leaders have lied to their members and said that the whole forest will eventually be shut down, in order to scare people into going along with their plan.**
