This letter of agreement shall memorialize the agreement and understanding between the Village of Lake Barrington and the Sierra Club as follows:

- (1) The Village of Lake Barrington agrees to promptly provide to the Sierra Club copies of reports the Village receives from the Village of Wauconda pursuant to the terms of the "Intergovernmental Agreement Between the Village of Lake Barrington, the Village of Wauconda and the Township of Cuba Relative to Fiddle Creek" (hereinafter sometimes referred to as the "Intergovernmental Agreement"), including, but not limited to, Discharge Monitoring Reports and all information gathered through effluent and monitoring well testing, as set forth in Sections 2 and 3(E) of the Intergovernmental Agreement.
- (2) The Village of Lake Barrington agrees to notify the Sierra Club of the date and time of collection of all effluent and monitoring well water samples sufficiently in advance of the scheduled collection so that members and/or staff of the Sierra Club may be present for said collection, as set forth in Section 3(E) of the Intergovernmental Agreement.
- (3) The aforesaid reports and notification provided to the Sierra Club will, if possible, be made by the Village of Lake Barrington via electronic mail addressed to the following:
